The Commission met in regular session through teleconferencing with Mayor Mary Hornek and the following Commissioners:

Others present: City Treasurer Chris Lusher and City Clerk Barbie Bryant.

The Mayor called the meeting to order at 7:00pm via Zoom.

MINUTES

The minutes from the 11-15-2021 regular meeting were presented. **UPON MOTION OF COMMISSIONER HAMMOND, DULY SECONDED BY COMMISSIONER DITTMER, THE MINUTES FOR THE 11-15-2021 REGULAR MEETING WERE APPROVED AND CARRIED BY A VOTE OF 5-0.**

FINANCIAL REPORT

Treasurer Lusher presented the Income Statements and the Balance Sheets for November, 2021. **UPON MOTION OF COMMISSIONER HAMMOND, DULY SECONDED BY COMMISSIONER JONES, THE INCOME STATEMENT AND BALANCE SHEETS FOR NOVEMBER 2021 WERE APPROVED AND CARRIED BY A VOTE OF 5-0.**

The minutes will reflect that Commissioner Schroeder will complete the oversight checklist and that the bank statements were available for review.

Mayor Hornek announced that she will present the monthly outline of assignments for 2022 in January. Each Commissioner will be assigned a month to perform the oversight checklist. Commissioner Hammond has agreed to the month of January to get the process going.

POLICE REPORT

Chief Spann had emailed his updates to the Commissioners for their review. Discussion will be provided during Commissioner Jones' monthly report.

MAYOR'S REPORT

Mayor Hornek announced that the berm sign may be in place after the first of the year. Contracts have been signed and completed for Naturescape Lawn Service and Walsh Brothers Snow Removal.

Mayor Hornek asked the Commissioners to consider which department they would like to handle for next year. The assignments will be allocated in January. The position of Mayor ProTem will be chosen in January as well.

Mayor Hornek reminded the Commissioners that if they anticipated running for a seat in the 2022 election, they would need to register with the Jefferson County Clerk Election Board by June 07, 2022. She provided the street address and the email address where forms are available.

Mayor Hornek presented an opportunity to provide funds for Meadow Vale City employees as stimulus payments. The Treasurer, Clerk and Office Assistant would receive \$3,000 each and the Police Chief, Sergeant and Officer would receive \$5,000 each. **COMMISSIONER DITTMER MOTIONED TO USE FUNDS TO PAY EMPLOYEE STIMULUS PAYMENTS AS PRESENTED IN THE MAYOR'S REPORT. THE MOTION WAS DULY SECONDED BY COMMISSIONER JONES. THE MAYOR CALLED THE ROLL AND THE FOLLOWING VOTED:**

Commissioner Schroeder (Utilities) provided the following report:

On November 29th, the bricks structures at the entrance at Meadow Vale Drive and Hounz Lane were pressure washed in preparation for the new signs.

Commissioner Jones (Public Safety) reported that Chief Spann has been notified that he may be sent to Muhlenburg County to provide emergency police protection to the area.

He also reported that the City of Middletown has a 2011 Ford Crown Vic they will give to Meadow Vale to be used by the police. The car has over 155,000 registered miles. After some discussion, Commissioner Jones will contact the Middletown Police Chief and decline the gift.
