07-18-2022 7:00PM - 8:15 PM

The Commission met in regular session at City Hall with Mayor Mary Hornek and the following Commissioners:

Others present: City Attorney Kerry Butler, City Treasurer Scott Pitts, Police Chief Ray Spann, Office Assistant Pat Teeter and City Clerk Barbie Bryant (via Zoom). Guests included Mayor of Rolling Hills Judy Crowe, Kelly Price, Leslie Hicks, Judy Engstrand, Pamela Neumann, Todd Jordon, Joseph Hornek, Dorothy Howard and Adam Monsky.

Mayor Hornek called the meeting to order at 7:00pm, followed by the pledge of allegiance.

MINUTES

The minutes from the 06-13-2022 special meeting were presented. UPON MOTION OF COMMISSIONER HAMMOND, DULY SECONDED BY COMMISSIONER JONES, THE MINUTES FOR THE 06-13-2022 SPECIAL MEETING WERE APPROVED AND CARRIED BY A VOTE OF 4-0.

FINANCIAL REPORT

Treasurer Pitts presented the Income Statements and the Balance Sheets for June 2022. UPON MOTION OF COM-MISSIONER JONES, DULY SECONDED BY COMMISSIONER SCHROEDER, THE INCOME STATEMENT AND BALANCE SHEETS FOR JUNE 2022 WERE APPROVED AND CARRIED BY A VOTE OF 40.

The minutes will reflect that Commissioner Schroeder will complete the oversight checklist and that the bank statements were available for review.

POLICE REPORT

Police Chief Spann reported on the intersection of Westport Road and Goose Creek Road that seems to be particularly hazardous by virtue of violators disregarding the automatic traffic control devise. He encouraged all to be aware of all roadway intersections and view them as potentially dangerous.

MAYOR'S REPORT

Mayor Hornek reported that the city has received the second tranche of funds from the Department of Local Government in the amount of \$101,416.41. UPON MOTION OF COMMISSIONER HAMMOND, DULY SECONDED BY COMMISSIONER JONES, THE RECOMMENDATION TO TRANSFER \$50,000.00 FROM THE ARPA FUNDS TO THE ROAD FUND INVESTMENT ACCOUNT WAS APPROVED AND CARRIED BY A VOTE OF 4-0.

Mayor Hornek will meet with Judy Dobbs, St Thomas Episcopal Church, on Tuesday to talk insurance, permits and other arrangements necessary for the Fall Festival event.

Mayor Hornek is very pleased with the work of the new Treasurer, Scott Pitts. He has transitioned into the roll quite easily and she feels he will be most qualified for the tasks ahead.

Mayor Hornek informed the Commission that the City of Rolling Hills will begin meeting at Plantation beginning in September of this year.

RESIDENTIAL DEED RESTRICTIONS

The deed restrictions were originated when Meadow Vale Subdivision was established. However, when the City of Meadow Vale was incorporated in 1967, the codified ordinances were considered the avenue for interpretations on complaints and legal issues. City Attorney Butler questions whether some deed restrictions that did not roll over into an ordinance may still apply to date.

DEPARTMENT REPORTS

Commissioner Hammond (Public Services) gave the following report:

- I was approached by a neighbor about a street block party. I thought it was a good idea and so Grenfell Way is having a "block party" on Saturday September 10th starting at 3pm. The neighbors were wondering if we could use some cones to block off Grenfell Way a bit so that people could mingle and walk down the street?
- The berm wall is graffiti free, and I have contacted LG&E about another street light issue.

Commissioner Dittmer (Community Services) emailed to the Commission the following report:

• Mary and I are meeting with Judy Daub at St. John's Episcopal Church, on Tuesday, July 26th.

Commissioner Schroeder (Public Safety) reported on the following:

- The concrete has been removed from the berm. The Weber group will mark the area and contact the Kentucky Department of Highways for inspection prior to the installation of the new sign. The new sign will be parallel to Hounz Lane.
- Speeding on Hounz Lane continues to be an issue. The Meadow Vale Police Department officers have been conducting traffic enforcement along Hounz Lane.

Commissioner Jones (Utilities) stated he had nothing new to report.

CITIZEN COMPLAINTS

There were two issues that pertained to separate properties located on Boxford Way. The first issue discussed was about the city's response and requested action for an "abusive neighbor". The second issue discussed was about whether a property could be used for anything other than a single-family dwelling. Research will need to be done on whether the property has secured the proper application approval for the zoning requirements.

ADJOURNMENT

BY CONCENSUS, THE RECOMMENDATION TO ADJOURN THE MEETING AT 8:15PM WAS APPROVED.

Police Blotter

Police Blotter: For our purposes, the definition of a "Police Blotter" is a written record of facts, meaningful events, interesting occurrences, traffic-enforcement matters, departmental strategies or crime prevention tips, when appropriate, incorporated into the city's monthly newsletter.

Vehicle Theft

On Thursday, 30 June 2022, during the very early morning hours, a vehicle was reported stolen from the 9800 block of Meadow Vale Drive. Apparently, the stolen vehicle's key fob was removed from another *unlocked* vehicle in the same driveway, which allowed the thieves to almost effortlessly abscond with the car. At the risk of sounding like a broken record, *PLEASE LOCK YOUR CAR DOORS*. I do not wish for you to become the next victim.

Traffic Enforcement @ Intersections & Recommendation

Significant to mention, all roadway intersections should be viewed as potentially dangerous, but more especially Westport Road at Goose Creek Road. This intersection is particularly hazardous by virtue of violators disregarding the automatic traffic control device. Within a week's period of time, two (2) FLAGRANT violators were cited traveling eastbound on Westport at Goose Creek for running the signal by about 3 seconds and at about 45+ MPH. It is an absolute miracle there was not a collision in either case due to Goose Creek vehicles already entering that intersection from both north and south directions. My recommendation: Nowadays if you are the first car stopped at the red light, a prudent course of action is to always pause momentarily and check/double check both ways BEFORE entering an intersection.

Louisville-Jefferson County Yardwaste Program

The Louisville-Jefferson County Waste Management District bans the mixture of yardwaste with municipal solid waste. All yardwaste is collected separately from residential waste. In accordance with the May 2014 Louisville-Jefferson County Waste Management District yardwaste container regulation (51.507R), yardwaste should be prepared in one of the following ways:



Placed loosely in a dedicated 30-35 gallon can clearly labeled "YARDWASTE"



Placed in 30-35-gallon paper yardwaste bags



Placed in compostable plastic bags (meeting the ASTM D6400 standards)



Rumpke 95-gallon yardwaste cart (additional monthly charge may apply).

Brush and branches should be cut and bundled. Branches should not exceed four feet (4") in length and three (3") in diameter or weigh more than 75 pounds per bundle.

Yardwaste is collected at the curb. If yardwaste and residential waste are collected at the curb on the same day, there should be a separation between the two waste streams to make identification easier for the collectors. All yardwaste is taken to a composting facility.

Yardwaste includes the following:

- Grass, weeds, and other lawn herbaceous materials.
- Shrubbery and plant clippings.
- Twigs, sticks, small branches within the above guidelines.
- Leaves.

Yardwaste does not include the following:

- Lumber
- Logs, stumps, or firewood.
- Tree branches uncut or exceeding the above guidelines.
- Large amounts of dirt or gravel.

Rumpke will collect Christmas trees for municipalities with yardwaste collection. Trees must be free of decorations and may be placed at the curb uncut. Rumpke reserves the right to place limits on the amount of yardwaste collected from individual residential units following severe storms, tornados, or other periods of severe weather. In any event, unless otherwise specified, Rumpke will abide by the guidelines of the Yardwaste Collection Program.
