CITY OF MEADOW VALE, KENTUCKY REGULAR COMMISSION MEETING MINUTES 05-20-2024 7:00PM – 8:28PM

The Commission met in regular session at City Hall with Mayor Matthew Hammond and the following Commissioners:

Commissioner Julie Michels
Commissioner James Wallover
Commissioner Brad Williams - absent

Others present: City Treasurer Chris Lusher, City Attorney Kerry Butler, Police Chief Jim Wilder, Office Manager Pat Teeter and City Clerk Barbie Bryant. Guests included Bill Pearce and Charles "Butch" Shipley. Mayor Hammond called the meeting to order at 7:00pm followed by the pledge of allegiance.

CITIZENS / GUESTS - REMARKS

Bill Pearce will need to purchase 15-20 bags of cypress mulch and several bottles of Round-Up to continue to maintain the landscaping around the city sign. UPON MOTION OF COMMISSIONER LUCAS, DULY SECOND-ED BY COMMISSIONER MICHELS, THE RECOMMENDATION TO ALLOW UP TO \$150.00 TO PURCHASE THE ITEMS WAS APPROVED AND CARRIED BY A VOTE OF 4-0.

Mr. Shipley stated he was attending to be able to relay information back to his neighbors.

MINUTES

The minutes from the 04-15-2024 regular meeting were presented. UPON MOTION OF COMMISSIONER LUCAS, DULY SECONDED BY COMMISSIONER WALLOVER, THE MINUTES FOR THE 04-15-2024 REGULAR MEETING WERE APPROVED AND CARRIED BY A VOTE OF 4-0.

FINANCIAL REPORT

Treasurer Lusher presented the Income Statements and the Balance Sheets for April 2024. UPON MOTION OF COMMISSIONER LUCAS, DULY SECONDED BY COMMISSIONER MICHELS, THE INCOME STATEMENT AND BALANCE SHEETS FOR APRIL 2024 WERE APPROVED AND CARRIED BY A VOTE OF 4-0.

The minutes will reflect that all bank statements were available for review. Commissioner Michels will be responsible for the April Checks and Balance report.

POLICE REPORT / CODE ENFORCEMENT

Commissioner Wallover reported on the following:

- Parking Issue with a Commercial Truck, Boxford Ct. has been resolved
- A Suspicious Person identified as a Solicitor was resolved by another agency
- House Watch: No Issues / Resident Returned Home
- Traffic Stop: Speeding / Westport & Hurstbourne Ln. (Warning)
- Officer Bacon has completed his "On the Job Training" and is patrolling on his own.
- All training up to date and In-Services have been scheduled. Office Bacon to be scheduled for In-Service at a later date

MAYOR'S REPORT

Mayor Hammond reported that the Community Yard Sale was a success. Over a dozen families within Meadow Vale participated. An issue with the contacts at PC Quest will be addressed and an email will be established for the new officer. The issue with authorization for gas cards has been remedied and each officer will receive their own card to better track usage.

Several issues with vehicle infractions within the city limits were directed to the Code Enforcement Officer for further investigation and possible citations.

Mayor Hammond and Commissioner Michels have conflicts for the regular date of the June Commission Meeting. UPON MOTION OF MAYOR HAMMOND, DULY SECONDED BY COMMISSIONER WALLOVER, THE RECOMMENDATION TO HOLD A SPECIAL MEETING ON JUNE 10, 2024 AT 7:00PM AT CITY HALL WAS APPROVED AND CARRIED BY A VOTE OF 4-0.

Mayor Hammond stated that the Annual ARPA Fund Report was submitted. The 2024 UFIR and Audit were received by the Department of Local Government.

Metro Louisville Zoning and Planning will conduct several workshops to discuss "Middle Housing" zoning regulations that will go into effect in 2025. Mayor Hammond suggested the Commissioners attend the sessions to get better acquainted with the new zoning proposals. He also encouraged all Commissioners, interested in re-election, to contact the County Clerk's office for paperwork.

PAMPHLET FOR MEADOW VALE RULES

Mayor Hammond shared with the Commission and those in attendance the pamphlet that will be distributed to residents and published in the June Newsletter. It highlights several issues that repeatedly are present in the city involving animals, vehicles and property maintenance.

RUMPKE EXTENDED CONTRACT FOR GARBAGE COLLECTION

The extended contract for years 2024 through 2026, approved in 2022, will increase monthly amounts from \$20.50 to \$21.63, effective July 1, 2024.

USER FEE FOR GARBAGE COLLECTION

Mr. Shipley expressed the number one concern regarding the User Fee. He questioned whether the fee would be paid on a monthly basis, quarterly or annually. Mayor Hammond and the Commission agreed the fee would be invoiced annually. The ordinance is currently being drafted by the City Attorney and the City Clerk and will be presented to the Commission in the July meeting. Discussion followed addressing penalties, possible liens and administrative duties.

ORDINANCE #39 ANNUAL BUDGET FY 2024-2025

Mayor Hammond introduced the ordinance and City Clerk Bryant presented the first reading in full as follows:

CITY OF MEADOW VALE ORDINANCE NO. 39, SERIES 2024-2025

AN ORDINANCE ADOPTING THE BUDGET FOR THE CITY OF MEADOW VALE, KENTUCKY FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025 BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT

WHEREAS, the annual budget proposal and message have been prepared and delivered to the City Commission, and;

WHEREAS, the City Commission has reviewed such budget and made necessary modifications.

NOW THEREFORE, BE IT ORDAINED by the City of Meadow Vale, Commonwealth of Kentucky that:

SECTION I

The budget for the City of Meadow Vale for the fiscal year beginning July 1, 2024 and ending June 30, 2025, shall be as attached hereto (see Attachment A):

SECTION II

This ordinance shall take effect on July 1, 2024, the first day of the fiscal year, after its passage and approval and publication as required by law.

No vote was taken.

ORDINANCE #40 LEVYING AN AD VALOREM PROPERTY TAX

Mayor Hammond introduced the ordinance and City Clerk Bryant presented the first reading in full as follows:

<u>CITY OF MEADOW VALE</u> ORDINANCE #40, SERIES 2024-2025

AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF ALL REAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF MEADOW VALE, KENTUCKY, AND THE LEVYING OF AN AD VALOREM TAX THEREON FOR CITY PURPOSES.

WHEREAS, pursuant to relevant provision of the Kentucky Revised Statutes, the City of Meadow Vale, Kentucky is authorized and empowered to provide a system for the assessment, levying and collection of all city taxes.

NOW THEREFORE BE IT ORDAINED by the City of Meadow Vale, Commonwealth of Kentucky that,

Section 1

The following provisions shall apply for the period of July 1, 2024 through June 30, 2025.

Section 2

The January 1, 2024 county assessment for all property situated within the City shall be the basis for this ad valorem tax levy.

Section 3

The City will utilize the services available from the Office of the County Property Valuation Administrator in the preparation and distribution of the tax bills and will reimburse said office at the statutory fee as required by KRS 132.285.

Section 4

Upon delivery of such tax bills, payment shall be made to the City of Meadow Vale. Collection of all delinquent taxes shall be made in the manner prescribed by law.

Section 5

The proceeds of such taxes are to be used for general operating purposes of the City and all other necessary and proper municipal functions.

Section 6

The ad valorem tax on residential and commercial real property as of July 1, 2024 through June 30, 2025 is hereby levied and fixed at the rate of \$0.107 per \$100.00 of property assessed for taxation.

Section 7

Said tax shall be due and payable on October 1, 2024. If the tax is paid after October 31, 2024, the bill shall be subject to a penalty of ten percent (10%) of the principal amount due, plus interest at the rate of 12% annum, together with all costs and expenses incidental to any action taken by the city for collection, including attorney fees of \$100 per lien, lien recording and release fees, and court costs.

Section 8

Any unpaid tax, together with collection costs thereon, as herein provided for, shall remain a lien against the property in favor of the City until fully paid.

Section 9

This ordinance shall take effect on July 1, 2024, the first day of the fiscal year, after its passage and approval and publication as required by law.

No vote was taken. City Clerk Bryant then announced that a public hearing on the proposed property tax will be scheduled for June 10, 2024 at 7:00pm at City Hall, 9408 Blossom Lane, Suite A, Louisville KY 40242.

RENTAL LICENSE – INCREASE ANNUAL FEE

The Commission would like to increase the annual rental license fee to \$400.00. The amended ordinance was reviewed by the City Attorney and will be presented at a later date.

DEPARTMENT REPORTS

Commissioner Michels (Community Services)

- Announced the Community Yard Sale was a success
- Is working on the July 4th of July Bike Parade
- Will produce a route for the parade and share it with the residents

Commissioner Lucas (Utilities)

- Will investigate the reason for the mowing of just portions of the berm
- Confirmed that the City pays to have the median between Hurstbourne Parkway and the berm mowed as part of the overall annual contract

ADJOURNMENT

UPON MOTION OF MAYOR HAMMOND, DULY SECONDED BY COMMISSIONER MICHELS, THE RECOMMENDATION TO ADJOURN THE MEETING AT 8:28PM WAS APPROVED AND CARRIED BY A VOTE OF 4-0.

Thursday, July 4th, 10am Begins on Meadow Vale Court



NEIGHBORHOOD NEWS

Dear Meadow Vale Residents:

Please review the below reminders about important ordinances in the city of Meadow Vale. Many of these impact the cleanliness and safety of our community and quality of life for our neighbors on a daily basis.

VEHICLES

Inoperable vehicles cannot be parked or kept on the property or street, must be kept in a garage.

(OTHER ORDINANCES, Chapter 1, Section 3)

No work vehicle over 21 feet is allowed to park anywhere in the city. (OTHER ORDINANCES, Chapter 1, Section 5)

All vehicles must be parked in the driveway and not on the street or on the lawn.

(OTHER ORDINANCES, Chapter 1, Section 19)

Please remember that the speed limit inside the City of Meadow Vale is 20 miles per hour.

Always be aware of children riding bikes and residents going out for a walk.



Property owners need to keep front and back yards free of extreme growth, refuse, trash, garbage, and scrap materials. Not only is this a viewing nuisance to neighbors, but it also attracts pests and rodents. (OTHER ORDINANCES, Chapter 2, Section 1 - 5)

ANIMALS

Animals should not interfere with the quiet enjoyment of your neighbor's outdoor experience, which applies to excessive barking, offensive odors and the unsightliness of the property that would diminish the value of a neighbor's property.

It is unlawful for any person to have an animal that continually barks, howls, whines or threatens to attack people or other animals.

It is the responsibility of the dog owner to keep the dog on a lease and ALWAYS clean up after your dog. (OTHER ORDINANCES, Chapter 5, Section 2-3)

Please remember that Meadow Vale is a City, not an HOA or a subdivision. These Ordinances are not suggestions, and infractions carry penalties.

Thank you for being considerate of each other and for adhering to the Ordinances to keep Meadow Vale a safe and prosperous city for our residents.
