"Immediate family member" means: A spouse, a child or step-child who is not emancipated and who resides in the officer's or employee's household, a domestic partner who is an adult, unrelated by blood, with which an unmarried or separated officer or employee has an exclusive committed relationship, maintains a mutual residence, and shares basic living expenses. or a person claimed by the officer or employee, or the officer's or employee's spouse, as a dependent for tax purposes
